1. INTRODUCTION

Cyril St Clair Cameron was born at the family property Fordon, Nile in northern Tasmania in 1857, the second son of prominent pastoralist and politician Donald Cameron. Cyril Cameron's military career was to see him serve with the British Army, Tasmanian Defence Force and Australian Army between 1877 and 1916. His distinguished military service was notable for his involvement in a number of key military events including: -

- As Second Lieutenant with the 9th Lancers (British Army)
 participating in General Roberts advance from Kabul to Khandahar
 and the subsequent battle which ended the Second Afghan War in
 1880.
- As Major (Tasmanian Defence Force) commanding the first Tasmanian contingent to the Boer War in 1898 – the first Tasmanian Defence Force unit to serve overseas and the first to be involved in military action.
- As Lieutenant Colonel (Australian Army) commanding the Australian contingent to the Coronation of Edward VII in 1902 – the first Australian army unit to serve overseas under Australian Commonwealth legislation
- As Colonel (British Army) serving as part of General Sir Ian Hamilton's general staff and landing with the British Forces at Gaba Tepe, Gallipoli Peninsula on April 25th, 1915.

In February 1887 Cyril Cameron was appointed Sub-Lieutenant with the Royal South Down Militia and soon after that year was promoted to Lieutenant. In 1879 he transferred to the 1st Dragoon Guards as a Second Lieutenant and then in January 1880 he again transferred to the 9^h Lancers which had suffered significant losses in Afghanistan. In March 1880 he had joined the 9th Lancers in Afghanistan and took part in General Roberts march from Kabul to Khandahar and the battle of Kandahar in September that year.

Cyril Cameron was promoted to Lieutenant in January 1881 and was to serve with the 9^h Lancers in India until the Regiment returned to England in 1885. In 1887 he was promoted to Captain and married Margaret Honywood Hughes the daughter of General Sir William Hughes, Indian Army. Two years later in 1889 he was seconded from the 9th Lancers for service as Adjutant with the Queen's Own Royal Staffordshire Yeomanry Cavalry Regiment and then from 1892 he served as Adjutant to the 8th Yeomanry Brigade.

In 1894 he retires from service with the 9th Lancers and returns to Tasmania to the family property Fordon following the death of his father in 1890. He became actively involved in local government and was elected

Warden of Evandale in 1896. He maintained his strong interest in defence issues and in 1898 was commissioned at Captain in the Tasmanian Defence Force and officer in command of the Evandale Company of the 2nd Battalion of the Tasmanian Infantry Regiment.

Following the decision of the Tasmanian Colonial Government to contribute military forces to the Anglo-Boer War in South Africa Cyril Cameron was appointed Officer Commanding the 1st Tasmanian Contingent in October 1899. This appointment recognised his military experience and in particular involvement in active service in Afghanistan. Soon after the Tasmanian Contingent arrived at Cape Town in November, Cyril Cameron was promoted to Major in the Tasmanian Infantry Regiment.

The Tasmanian Mounted Infantry saw active service in South Africa under the command of Major Cameron. During this time, he was wounded and captured near Arundel after giving his horse to a wounded soldier. Following his release, he was wounded again in action at the Zand River in May 1900. In December that year the first Tasmanian contingent returned to Tasmania. In February 1901 he was promoted to Lieutenant Colonel "for distinguished services in South Africa" and later that year invested as a Companion of the Order of the Bath.

During his service in South Africa, Cyril Cameron had become an extremely popular figure with the Tasmanian community. Soon after his return, he successfully stood as a Tasmanian representative for the Senate in the first Commonwealth elections held in April 1901.

In 1902 Cyril Cameron was appointed to command the Australian military contingent to represent Australia in the ceremonies associated with the coronation of Edward VII in London. This was to be the first Australian military continent to serve overseas under Commonwealth legislation.


At the beginning of 1903 Lieutenant Colonel Cameron was appointed the Commanding Officer of the 12th Australian Light Horse Regiment. He was to be involved with this Regiment and its successors as Commanding Officer and then Honorary Colonel for the next two decades. In December 1903 lost the election for the Senate but in 1906 he was again elected to the Senate to represent Tasmania and was to continue to do so until 1913. During this time, he spoke frequently on defence matters and the development of Australia's military capacity including the need for universal military training.

Following the declaration of war in 1914 Lieutenant Colonel Cameron travelled to Britain arriving in November that year. He returned to service with the British Army, was promoted to Colonel and joined General Birdwood's general staff in Egypt in December. He then served as adjutant general on General Sir Ian Hamilton's staff in the planning for the landings on the Gallipoli Peninsula. He landed with the British 3rd Brigade

at Gabe Tepe on April 25th. In June 1915 at the age of 57 he was invalided from Gallipoli, returned to Australia in August and was not to return to active service.

Colonel Cameron continued his strong interest in defence issues until his death at Fordon in December 1941. His three eldest sons were all to serve in the British Army.

- 1884 (30th April) Lieutenant Cameron arrived in Launceston having been granted furlough for 15 months (Daily Telegraph 1/5/1884)
- 1885 (November) The 9th Lancers including Lieutenant Cameron returned to Britain
- 1887(March) Promoted to Captain (North Western Advocate and the Emu Bay Times 18/10/1899)
- 1887 (30th August) Captain Cyril St Clair Cameron married Margaret Honywood Hughes at Anglican Church, Bovey Tracey, Devon (The Mercury 14/10/1887)
- 1889 (15th October) 1894 Captain Cyril St Clair Cameron seconded from 9th Lancers, for service as Adjutant of the Queen's Own Royal Staffordshire Yeomanry Cavalry (London Gazette 20/9/1889, 15/10/1889) (Advocate 31/8/1937)
- 1892 (13th October) Captain Cyril Cameron arrived in Hobart from London (The Mercury 14/10/1892)
- 1892 1894 Adjutant of the 8th Yeomanry Brigade / Brigade of Staffordshire and Warwickshire Yeomanry Regiments (Advocate 31/8/1937)
- 1894 (27th June) Captain Cyril St Clair Cameron retires from the Service (9th Lancers) receiving a gratuity with permission to retain his rank and wear the prescribed uniform (London Gazette 26/6/1894)

- 1894 Returned to Fordon, Nile
- 1894 (5th December) Captain Cyril Cameron attended meeting at White Hills and nominated for election to Evandale Council (The Examiner 7/12/1894)
- 1895 Placed on British Army reserve list
- 1896 (11th December) Elected Warden of Evandale (Daily Telegraph 14/12/1896)
- 1898 (29th August) Commissioned Captain in Tasmanian Defence Force and officer in command of the Evandale Company of the 2nd Battalion Tasmanian Infantry Regiment (The Examiner 30/08/1898)
- 1899 (October) Captain Cyril St Clair Cameron appointed Officer Commanding 1st Tasmanian Contingent for South Africa which left Tasmania on 27^h October (The Mercury 14/10/1899) and arrived in Cape Town on 26th November.
- 1899 (17th December) Promoted to Major in Tasmanian Infantry Regiment (Acc. No. 465)
- 1900 (24th February) Wounded and captured near Arundel after giving horse to wounded soldier
- 1900 (10th May) Wounded again at the Zand River
- 1900 (27th November) Granted temporary rank of Captain in British Army whilst serving in South Africa (London Gazette 5/9/1905)
- 1900 (7th December) Contingent returned to Tasmania
- 1901 (28th February) Promoted Lieutenant Colonel "for his distinguished services in South Africa" (The Examiner, Daily Telegraph 28/2/1901)
- 1901 (5th April) Cyril Cameron elected to represent Tasmania in first Australian Senate (Tasmanian News 6/5/1901)
- 1901 (6th April) Lt Colonel Cameron present at Easter Camp at Ross (The Mercury 8/04/1901, Tasmanian Mail 13/04/1901)
- 1901 (16th April) Major Cyril St Clair Cameron awarded Mentioned in Dispatches (London Gazette 16/04/1901)
- 1901 (19th April) Major Cyril St Clair Cameron awarded Companion of the Order of the Bath (London Gazette 19/4/1901, Daily Telegraph 22/04/1901)
- 1902 (28th April) Lieutenant Colonel Cameron participated in Easter Camp at Ross (Examiner 1/4/1902)
- 1902 (16th April) "The Minister of Defence (Sir John Forrest) has decided that

1903 (30th December) Cyril Cameron lost Senate re-election (Tasmanian News 30/12/1903)

1904 (20th February) Lieutenant Colonel Cameron unveiled the Boer War Memorial, Launceston (The Examiner 17,20,22/02/1904) Sir Edward Hutton inspects northern troops at Launceston, Lieutenant Colonel Cameron present (The Examiner 22/02/1904)

1904 (23rd February) Lieutenant Colonel Cameron present at the Tasmanian Centenary Celebrations at the Domain, Hobart (The Mercury 24/2/21904)

1904 (1st April) Lieutenant Colonel Cameron participated in the Easter Camp at Ross (The Mercury 4/4/1904)

1904 (14th November) Lieutenant Colonel Cameron Commanding Officer of the 12th ALH, part of party to receive the regimental colours from H E Governor General in Melbourne (The Examiner 18/11/1904)

1904 (9th December) Lieutenant Colonel Cameron elected Warden of Evandale (The Examiner 10/12/1904)

1905 (1st February) Lieutenant Colonel Cameron present at the unveiling of the National Boer War Memorial in the Domain, Hobart by the Governor (The Mercury 2/2/1905)

1905 (28th February) Lieutenant Colonel Cameron a member of the party welcoming their excellencies Lord and Lady Northcote, at Launceston, this being the first time this Governor General had visited Tasmania (Daily Telegraph 1/3/1905)

1905 (25th April) Lieutenant Colonel Cameron participated in the Easter Camp for Light Horse at Pontville (The Mercury 26/4/1905)

1905 (12th July) Lieutenant Colonel Cameron participated in Military Gymkhana at Sheffield (Daily Telegraph 14/7/1905)

1906 (12th April) Lieutenant Colonel Cameron in command of Easter Camp for Light Horse at Mona Vale near Ross (The Mercury 16/04/1906)

1906 Re-elected to Senate and continued to sit until 1913 (Daily Telegraph

17/12/1906)

- 1907 (29th March) Lieutenant Colonel Cameron in command of the Light Horse at the Easter Camp held at Mona Vale (The Mercury 29/03/1907)
- 1909 (11th April) Lieutenant Colonel Cameron participated in Easter Camp for Light Horse at Mona Vale (The Examiner 14/04/1909)
- 1910 (8th February) Lieutenant Colonel Cameron participated in special military camp at Ross observed by Lord Kitchener (Daily Post, The Examiner 09/02/1901)
- 1911 (14th April) Lieutenant Colonel Cameron in command of the Light Horse at the Easter Camp held at Mona Vale (Daily Telegraph 15/04/1911)
- 1912 (18th March) Lieutenant Colonel Cameron officer commanding 12th ALH in command at the Easter Camp held at Mona Vale (Daily Post 21.03/1912)
- 1912 (1st July) The 12th Australian Light Horse Regiment redesignated the 26th Light Horse (Tasmanian Mounted Infantry) (Military Order 277) Lieutenant Colonel Cameron continues as Commanding Officer
- 1913 (22nd February) Lieutenant Colonel Cameron present at military gymkhana held at the Elphin showgrounds (The Examiner 24/02/1913)
- 1913 (21st March) Lieutenant Colonel Cameron in command of 26th Light Horse for part of the Easter camp held at Mona Vale. Incident alleging, he introduced alcohol to the camp. (The Mercury, Daily Post 24/03/1913)
- 1914 (September) Lieutenant Colonel Cameron contests federal senate election and loses seat. (Daily Post 18/09/1914)
- 1914 Lieutenant Colonel travelled to Britain arriving late November where promoted to Colonel in the British Army and appointed as assistant adjutant general to General Birdwood and travelled to Egypt. (Daily Telegraph 14/12/1914, Critic [Hobart] 18/12/1914, The Mercury 12/03/1915)
- 1914 (28th December) Lieutenant Colonel Cameron speaks to the Tasmanians of the 3rd Light Horse in Egypt (Daily Telegraph 27/01/1915)
- 1915 Lieutenant Colonel assistant adjutant general on General Sir Ian Hamilton's staff at the Gallipoli landing
- 1915 (25th April) landed in the morning at Gaba Tepe, Gallipoli with 3rd Brigade (Zeehan and Dundas Herald 30/08/1915)
- 1915 (15th June) Invalided from Gallipoli (Zeehan and Dundas Herald 30/08/1915)
- 1915 (26th August) Colonel Cameron returned to Australia on sick leave

(Zeehan and Dundas Herald 30/08/1915, Daily Telegraph 6/09/1915)

1915 (1st September) Colonel Cameron honoured by the Australian Senate meeting in Melbourne by being invited to sit in the chamber beside the President (Daily Post 2/09/1915)

1915/1916 Colonel Cameron returned to London considering that he was fit to return to active service (Daily Post 26/01/1916)

1916 (January) Hon. C St Clair Cameron CB appointed to be Honorary Colonel of the 26th Light Horse (Tasmanian Mounted Infantry) (The Examiner 11/01/1916)

1916 (15th August) Colonel Cameron returned to Tasmania and spoke at the public welcome for the arrival at Evandale of Lieutenant Colonel Hawley who was wounded at Gallipoli (The Examiner, The Mercury 16/08/1916)

1916 (3rd September) Colonel Cameron welcomed back as Councillor at the September 3rd meeting of the Evandale Council (Daily Telegraph 7/09/1916)

1917 (17th April) Lieutenant Colonel Cameron announced his intention to stand for the Senate and "intended making conscription the main plank of his platform as men were urgently needed at the front" (Zeehan and Dundas Herald 18/04/1917)

1918 (24th May) Lieutenant Colonel Cameron present and speaks at unveiling of the Evandale Roll of Honour at the Council Chambers (The Mercury 25/05/1918)

1919 (10th October) Lieutenant Colonel Cameron present at the reunion of the 26th Light Horse Regiment at the Albert Hall (The Examiner 11/10/1919)

1921 Appointed Honorary Colonel of the 22nd Light Horse, Tasmanian Mounted Infantry

1941 (22nd December) Died at Fordon, (Examiner, The Mercury 23/12/1941)

1875 (9th January) 9th Lancers embarked for India stationed at Sialkot, Kashmir

1877 Diary of Captain Stewart Mackenzie,9th Lancers,15th April – 4th June 1877

1878 (December) 9th Regiment moved to Taru near Peshawar in preparation for involvement in Afghanistan

1879 (13th March) Regiment under command of Lt Col H Bushmen moved through Khyber Pass as part of the Cavalry Brigade led by General Gough. Most of Regiment detailed to hold the Pass.

1879 (6th October) One squadron involved in the Battle of Charasiab and occupation of Kabul on the 8th October

1879 (4th November) Regiment's squadrons reunited at Kabul

1879 (December) Regiment involved in a number of engagements around Kabul

1879 (11th December) Regiment involved in major action at Killa Kazi in which 2nd Lieutenant W. P. Ricardo was killed and Captain Stewart Mackenzie mentioned in despatches

1880 (1st January) Regiment served in 1st Division Northern Afghanistan Field Force (until 8 h August)

1880 (16th February) Lieutenant Cameron leaves Bombay for Kabul

1880 (March) Lieutenant C. St C. Cameron commenced service with regiment taking part in the march from Kabul to the relief of Kandahar and battle of Kandahar

1880 (8th August) Regiment leaves Kabul under command of Lord Roberts for Khandahar as part of the Kabul-Khandahar Field Force

1880 (1st September) Regiment involved in Battle of Kandahar and the relief of the city.

1880 (20th November) Regiment commences return to quarters at Umballa, India – Cameron remains in Khandahar Hospital with typhoid

1881 (1st January) Cameron rejoins the Regiment at Umballa where he was granted six months "sick leave" to Tasmania

1885 (23rd November) Regiment left Umballa, India and returned to England

- (17th June) Contingent disembarked Albert Docks, London and quartered in Alexandra Park
- (19th June) Paraded with other Coronation contingents before the Duke of Connaught at Alexandra Palace (Tasmanian News 20th June)
